Furthermore, if the data processing is based on consent or on the contract and is carried out with automated tools, the data subjects are entitled to receive the data in a structured, commonly used and automatically readable format, as well as, if technically feasible, to transmit them to another Data Controller without impediments. Data subjects have the right to revoke the previously given consent at any time for marketing and/or profiling purposes, as well as to object the processing of data for marketing purposes, including profiling related to direct				

marketing. Those data subjects who prefer to be contacted for the aforementioned purposes exclusively through traditional methods still have the possibility to object when a communication is received through automated methods.
