<b>RIGHTS OF THE DATA SUBJECTS – COMPLAINT WITH A SUPERVISORY AUTHORITY</b> By contacting the office in Via Cavalcavia, 157 or by e-mail to max.montalti@mwmitaly.com, data subjects can ask the Data Controller to access their data, ask for their erasure, the rectification of incorrect data, the integration of incomplete data, the restriction of processing in the cases provided for by art. 18 GDPR. They also have the right to object to the processing in the hypothesis of legitimate interest of the Data Controller.					



Furthermore, if the data processing is based on consent or on contract and is carried out with automated tools, the data Subjects are entitled to receive the data in a structured, commonly used and automatically readable format, as well as, if technically feasible, to transmit them to another Data Controller without impediments.

Data Subjects have the right to revoke the previously given consent at any time for marketing and/or profiling purposes, as well as to object the processing of data for marketing purposes, including profiling related to direct marketing. Those data Subjects who prefer to be contacted for the aforementioned purposes exclusively through traditional methods still have the possibility to object when a communication is received through automated methods.

Data Subjects shall have the right to lodge a complaint with a Supervisory Authority, in particular in the Member State of their habitual residence, place of work or place of the alleged infringement.
